

# ARTISTS ASSIGNMENT

THE UNDERSIGNED ARTIST IS ASSIGNED AS FOLLOWS AND AGREES TO PERFORM IN ACCORDANCE WITH THE CONTRACT WHICH WILL BE SIGNED IN CONJUNCTION WITH THIS ASSIGNMENT BY THE OWNER OR THE CLUBS REPRESENTATIVE AGENT ON LOCATION AT THE TIME OF THIS ASSIGNMENT.

**PERIOD OF CONTRACT:** Thirteen(13) weeks (one week is considered six (6) complete nights of work regardless of the number of nights taken off in between). Suitable shared Artist only housing provided as long as house rules are followed. (Utilities paid by Artists living in housing). Airfare to Guam provided by Artist can be advanced by the club to the Artist but must be paid back thru the first two or three weeks pay and commissions earned. If the Artist satisfactorily completes 13 weeks work, as agreed, the Owner will reimburse the Artist the cost of the coach one-way airfare to the assigned location from the West Coast of the United States, and will provide her with return coach airfare to the same West Coast city the Artist departed from. (Airfare reimbursement is set at a maximum of \$2,200.00. The Artist is responsible for any costs over that amount.) Contract can be extended for any duration of time as long as the terms and conditions remain in effect during the extension and such extension is agreed to by the Owner and Artist in its entirety.

**COMPENSATION:** The Owner will pay the Artist up to \$450.00 per six complete nights on stage, (less \$50.00 Agents commission, if applicable) housing (provided house rules are followed and utilities are paid by the Artists), airfare (up to \$2,200.00) to and from the assignment as long as 13 weeks are completed satisfactorily, and 50% of any drinks, table dances, VIP dances or private parties she attends as well as 100% of all tips received on stage while dancing.

**SPECIAL INSTRUCTIONS:** Artist to perform to pre-recorded CD's or computer loaded music of about 18 to 23 minutes each. Rock n' Roll, easy listening preferred, but bring what you like, we'll work it out. The Artist to wear appropriate outfits on stage and on the floor mixing with customers. As with music, Owners discretion as

to what is appropriate, As luggage on airplanes is limited you should not bring any sheets or towels as we have the world's largest Kmart and ROSS stores here where you will be able to get anything you may need. **You must have the name of the songs you dance to so we can load in our computer for playing and you now can load them into a portable device such as a thumbdrive or an ipod but you still must have the names of the songs for loading as they do not always transfer and preferably not MP3's. PLEASE NO I-TUNES unless gonna use your own Ipod or Iphone to play.**

If this assignment and Contract are executed by the Artist's or Owner's Agent, the Artist and Owner will hold said Agent free from any liability or damages sustained by the Artist or the Owner should either breach them. This Agreement and Contract is play for pay other than an Act of God. The Artist is an independent Contractor and assumes all liability for Federal Withholding Taxes, Social Security and Medicaid Taxes, Public Liability and Workman's Compensation Insurance as well as any Health Liability or Health Insurance. If the ticket is to be advanced to the Artist to facilitate the arrival of the Artist, it is agreed, the Owner may deduct from the Artist's first two or three weeks pay and drink/dance commissions, if necessary, in order to repay the Owner this advance in pay as well as the \$200.00 utility security deposit for the dancer housing provided by the Owner. The Artist recognizes this as a debt and agrees to repay the Owner should she not finish 13 weeks work for any reason whatsoever at no fault to the Owner, the Corporation, or the Clubs assigned.
